











Foreword by the Chairman

comprehensive review of LINK's organization and constitutional obligations was conducted during the earlier part of the reporting period and this formed the foundation of the way ahead for an improved service to the Membership. Subsequently, the Management Team have been able to focus their limited resources more closely on an ever broadening array of environmental issues with significant success, covered later in the Report.

Better public awareness and political profile of the environment in Scotland has resulted in an increased requirement for LINK to engage more closely with the Scottish Executive and, in particular, facilitate the collective representation of Member bodies. This improved access is being complemented by an enhanced, timely service from the Parliamentary Officer. Additionally, in recognising the important influence that European Parliament regulations have on United Kingdom legislation, the possibility providing Members with intelligence on such business is being investigated.

There is no doubt that LINK has an important role to play in promoting the requirement for better consideration of environmental matters within both the public and private enterprise sectors and, in this respect, we foresee significant mutual benefits arising from earlier dialogue with industry. There is also a general growing appreciation and understanding that a greater proportion of financial investment will need to be made in respect of Scotland's environment and this is a matter which LINK will seek to influence on behalf of our Members. On a broader front, we continue

to raise awareness of, and promote, environmental issues and related civic responsibilities, including education, within a wider context.

LINK draws together Scotland's main voluntary environmental organisations, providing them with a forum for information exchange, discussion and, in many cases, concerted action. To government and other wider interests it is an entry point for information about, and contacts in, the network. There is no doubt that where the movement works together through LINK it is able to add value to individual efforts.

The Management Team is aware of the increasing workload and responsibility collectively being undertaken by LINK but remains determined to ensure that the fundamental obligations to the charity are discharged and that new commitments are not undertaken to the detriment of core business - in acknowledging the Management Team's appreciation of the Membership's contribution to the work of LINK, it is worth remembering that therein lies the strength of our organization.

Finally, I would wish to thank our dedicated and loyal headquarters staff for their sterling efforts on our behalf; they have coped admirably with a very demanding workload, overcome daunting challenges and provided us all with a first class service of which they can be justly proud and for which we are all profoundly grateful.
