Scottish Environment LINK response

Scottish Environment LINK have some serious concerns with the proposals put forward in this consultation. In particular, we would be concerned about any changes which could reduce the level of scrutiny required for developments which could affect designated sites. While we support improvements to digital infrastructure, Scotland's designated sites represent the very best, and often the most sensitive, parts of Scotland's environment. It is therefore essential that there is a mechanism to ensure that proposals are scrutinised, that environmental impacts are fully considered and that there are opportunities to involve the public and other stakeholders in the decision making process. This would help ensure that improved digital connectivity can be delivered without harming the most important parts of our environment. We would therefore oppose these changes as currently proposed.

The ongoing difficulties relating to agricultural and forestry tracks illustrates the type of problems that can occur when permitted development rights are applied without full consideration of the environmental consequences.

Despite our concerns about these current proposals, we are keen to help facilitate improved digital connectivity in Scotland and would be happy to discuss our concerns further to see how these issues may be resolved.

Because these changes could result in some significant environmental effects as proposed, if it is decided to pursue them it seems inevitable that an SEA would be required.
