## Scottish Government's Action Plan on European Engagement

# *European Commission's consultation on policy options to address indirect land use change*

Topical for LINK at the moment as we look at sustainable land use. **This consultation response** mainly focuses on the role that biofuels can and should play in climate change mitigation, and in particular in the debate regarding damaging land use change effects.

#### Barroso Re-elected as President

In Mid September (16<sup>th</sup>) Jose Manuel Barroso won backing of the EU Paralimant to return as President of the comission. It will be Mr Barroso's second five-year term as Commission President.

During his capaign for re-selection Barroso outlined his manifesto in 'Political guidelines for the next Commission, There's a useful environmental questioning of this in a letter the Eeb sent to all MEPs ahead of their vote.

"we regret a complete lack of attention for the environmental challenges the EU and the world are facing. Mr. Barroso seems to reduce this challenge to the one of climate change. But even this major issue – which is strongly linked to the issue of security receives little attention.

The EEB have in the past been highly critical of the environmental performace of the comission led by Barroso. A 'congratulatory' letter to the president highlighting where they believe action is required, and picked up on many of the concerns utline above (in the MEP letter).
