

1. General News

The European Citizens Initiative (ECI)

In a simple sound-bite the European Citizens Initiative, or ECI as it's already being shortened to, is "a million signatures to get a EU law changed", but of course it's a bit more complex than that.

"not less than one million citizens who are nationals of a significant number of Member States may take the initiative of inviting the Commission, within the framework of its powers, to submit any appropriate proposal on matters where citizens consider that a legal act of the Union is required for the purpose of implementing the Treaties."

The ECI is part of the Lisbon treaty, and the details of how it will work are still being discussed (a consultation on a **green paper** has just closed). For example what a significant number of member states is still hasn't been decided.

The broad features of citizens' initiatives are already laid down in the Lisbon treaty - namely that they must:

- have at least 1 million signatories, from a significant number of EU countries
- concern a policy area where the Commission has powers to act...
- and an issue for which people think an EU law is needed to implement the EU Treaties.

The commission will be using 2010 to look at drafting regulations relating to the ECI and it should be operational in early 2011. Some issues that they are looking at sorting our include registration of proposals (and transparency around who's backing them), language, IT standards, permissibility and adjudication. That hasn't stopped some people going ahead with getting one organised thought (eg GM petition)

I attended a seminar hosted by the EU Parliament's Scotland office last week, so if you want to talk more about this let me know.

7th European Action Plan (EAP)

Following on from our last **euro-bulletin**, which gave some background on the EAPs, Jonny Hughes (SWT) from the LINK board attended a seminar organised by the European Environmental Bureau (EEB) on developing the 7th EAP. The 6th EAP expires in 2012, so work starts now on shaping the next one.

This seminar was meant to be the first step towards a position of the EEB on what a new Environmental Action Programme for the EU should focus on. This position is going to be developed in the period till mid June, when the Board of the EEB will discuss and hopefully adopt it. This position is then going to play a key role in the further debate on whether a 7th EAP is needed and what is should be about.

IUCN European Redlist

The European Red List – compiled using the same criteria as the global IUCN Red List of Threatened Species[™], but limited to Europe – is a review of the conservation status of c. 6,000 European species (mammals, reptiles, amphibians, freshwater fishes, butterflies, dragonflies, and selected groups of beetles, molluscs, and vascular plants). It identifies species that are threatened with extinction at the regional level so that conservation action can be taken to improve their status.



The European Red List is primarily funded by the European Commission. The Commission is currently developing its position for a new global target to halt the decline in biodiversity to be discussed at the Convention on Biodiversity COP in Nagoya in October.

Forests Green Paper

At the start of March 2010 the Commission launched a green paper which sets out the main challenges facing Europe's forests. It presents existing forest information systems and the tools available to protect forests, and raises a series of questions relevant to the development of future policy options. The paper is part of the follow-up to the White Paper on adapting to climate change adopted by the Commission in April 2009.





Since competence for forest policy lies primarily with the Member States, the debate focuses on how climate change is modifying forest management and protection in Europe and how EU policy should evolve to enhance its contribution to Member State initiatives.

The consultation runs from the 1st March until the 31st July 2010.
