Notes on the Devolution Seminar held in Birmingham in October include the actionbased agreements were made, such as the biodiversity groups agreed to work together on an issue based basis and to exchange workplans to aid in that process. Other things that the Links agreed to consider in their future work were how to add value to the post climate change delivery agenda, how to share skills and knowledge more, and exploration of an 'added value test' for all Joint Links work and the idea a safe forum for Links to explore potentially contentious issues.
