June's Board discussions focussed round LINK's funding position and needs, trustee recruitment and particular skills needs to recruit for over the coming two years, developing the Organisational Supporter initiative, mapping LINK's connections across Scottish policy sector, following up June networking actions in particular the 30 August seminar and our governance paper/initiative. Andy is now revising the governance paper for wider Scottish distribution in mid -August.

#### **Chief Officer Report**

For Jen, July has included prep for the AGM with the Board, and follow-up of June Board actions including funding liaison, skills auditing, progressing our President search, and preparing the ground for the strategic review with members (details to follow in August). Gareth will also attend our economics seminar.

Liaised with Chair over priority issues for first meeting with Minister (October) amongst which are: Environment funding and Spending Review; Funding for LINK and eNGO sector; Future of Biodiversity. We'll be in touch with members with more information about the meeting, during August.

# North east marine surveys

This week a team of marine scientists from Scottish Natural Heritage, the British Geological Survey and the Northern Lighthouse Board, will begin a survey of the waters around Noss Head, near Wick, and the Southern Trench, a deep underwater channel in the outer Moray Firth. Using acoustic multibeam survey techniques to create a 3D image of the seabed, the information gathered will be used to identify marine habitats of high conservation value. This is one of a series of surveys being carried out around the coast of Scotland this year, the findings will be used to advise the Scottish Government and others on conservation and development in the marine environment. The area around the Southern Trench is frequently visited by minke whales and features a deep and distinctive gouge in the seabed, formed during the last ice age. However, relatively little is known about this area. A previous survey carried out off Noss Head for Scottish and Southern Energy in 2010, revealed a bed of horse mussels that maybe the largest in Scottish waters. Apart from this discovery, there is scant information on marine wildlife in the area. More details of SNH's draft list of priority marine features are here.

<u>Edinburgh Centre on Climate Change</u> – The Centre, which has received £1.6m in funding from the Scottish Government, unites policy makers, business and civil leaders with experts in finance, law, management and urban design to develop solutions to deliver the low carbon industrial revolution.

<u>Woodland Carbon Code is launched</u> - This voluntary code will encourage a consistent approach to woodland carbon projects, and offer clarity and transparency to customers about the carbon savings that their contributions may realistically achieve.

Scottish Government Announces £7 million for the Third Sector - The Just Enterprise programme will provide business support to those looking to set up or develop a social enterprise. It also includes an on-line 'hub' where organisations can get support and assistance. The Enterprise Growth Fund will give grants of between £25,000 and £200,000 to third sector organisations that want to secure their long-term sustainability by developing organisational structures or income streams.

# **PUBLICATIONS**

**The Scottish SEA Review** - a review of the efficiency and effectiveness of SEA in Scotland. SEPA led this work on behalf of the three Scottish Consultation Authorities and with the support of the Scottish Government. It was informed by a project steering group comprising of SEA practitioners from across Scotland.



The International Dimensions of Climate Change - published by the UK's Foresight programme, an overview of the evidence of threats and opportunities to the UK from international climate change, which considers how these may be considered by policymakers to ensure the UK is able to remain competitive, secure and able to protect the wellbeing of the nation.

Adapting to climate change in the UK: measuring progress - Adaptation Sub-Commitee Progress Report - July 2011. The ASC's 2nd assessment of how well the UK is prepared to deal with climate change impacts and risks. It sets out a range of indicators against which the UK's progress will be measured, and focuses on three priority areas of land-use planning, managing water resources, and the design and renovation of buildings as adaptation measures.

National Statistician's Reflections on the National Debate on Measuring National Wellbeing published by the ONS following the national debate on what influences people's well-being

<u>The Sustainable Lifestyles Framework</u> – published by DEFRA. A tool for organisations such as local authorities, civil society organisations and business to develop effective approaches to influencing behaviour.

<u>CNPA Supplementary Planning Guide to Wildness</u> - The Cairngorms National Park Authority is the first in the UK to issue special planning guidance to help protect wild land. The new rules mean that future planning applications in the park will have to be considered against their impact on wildness. There is also recognition that wildness can be enhanced by removing redundant structures such as old electricity pylons.

An analysis of the impact on the natural heritage of the decline in hill farming in Scotland – report from SNH

<u>The Common Cause Handbook</u> – Published by PIRC, the Common Cause Handbook argues values and 'frames' play a key role in shaping our thoughts and actions, and must be taken into account when communicating issues such as climate change to others.

**Flooding in Scotland:** A consultation on Potentially Vulnerable Areas and Local Plan Districts from SEPA, seeks views on how the National Flood Risk Assessment identifies areas for flood risk management planning and was launched by the Minister for the Environment, Stewart Stevenson, at the Braid Burn in Edinburgh. Responses will help identify those areas in Scotland where public bodies should focus their efforts. Closing date is 15<sup>th</sup> August.

Crown Estate Inquiry – call for further evidence – The House of Commons Scottish Affairs Committee is taking further submissions on the Crown Estate in Scotland, in particular: How revenues raised by the Crown Estate Commissioners in Scotland could be best used for the benefit of local communities in Scotland?; At what level might those revenues be best administered: UK Treasury, Scottish Government or local authority level?; What processes might be put in place for the distribution and allocation of those revenues, in order to secure the maximum benefit for the people of Scotland? # EUROPE (LINK is a member of the European Environmental Bureau)

EEB calls on 44 parties to Aarhus Convention to make it a "gift" to RIO+20 - Addressing Environmental Ministers and other delegates in July during a high level panel discussion, EEB Secretary General Jeremy Wates said that it was important to remove obstacles for countries outside the United Nations Economic Commission for Europe (UNECE) area to accede to the Convention, and thus help increase environmental democracy globally. "This is a ground-breaking Convention which could dramatically improve the environmental rights of citizens globally. Ahead of next years Rio+20 conference, what better time than now is there to make it easier for non-UNECE countries to accede the Aarhus Convention? The parties should commit to adopting at their next session an amendment removing the requirement that accession by non-UNECE States is subject to approval by the MoP," said Wates.

#### Ministers back binding European forest agreement

Ministers have agreed to back plans to introduce a legally binding agreement to protect Europe's forests. Delegates also agreed to adopt resolutions that would help shape forest policy over the next decade. The ministerial agreement was signed at the sixth Forest Europe conference in Oslo, Norway. The Norwegian host chairman, Rural Affairs Minister Lars Peder Brekk, said the signing of two ministerial declarations was a fitting end to Norway's four-year leadership of the Forest Europe process. As well as signing the declaration to begin negotiations to establish a legally binding agreement (LBA), delegates also agreed to set a number of targets to be achieved by 2020. These included all European countries implementing a national forest programme, which needed to contain climate adaptation and mitigation strategies.



**European Commission's Budget Proposals plus commentary from CAP2020 The New CAP**- The same but different The Commission College debated for a long day before agreeing their proposals for the next Multi-Annual Financial Framework (MFF). The CAP (€372 billion) remains a sizeable element of the Budget but now accounts for a fractionally smaller share of the overall MFF cake than the Cohesion Policy (€376 billion). The two Pillars remain and the basic structure of the CAP is not radically altered although the formal objectives now reflect the priorities of Europe 2020 much more explicitly. Indeed promoting resource efficiency has pride of place in the new objectives along with 'smart, sustainable and inclusive growth'....(more)
