## Re: Environment Committee response to George Lyon's draft report on the CAP

We are writing on behalf of the Agriculture Groups of both Wildlife and Countryside Link<sup>1</sup> and Scottish Environment Link<sup>2</sup>, (whose members have the support of over 8 million people in the UK), regarding the forthcoming reforms of the CAP and George Lyon's report to the European Parliament Committee on Agriculture and Rural Development.

At a recent meeting that we held with George Lyon MEP, we requested that his draft report be shared and discussed with the Chair of the European Environment Committee as well as the wider Committee members. We understand that the Environment Committee has taken the decision not to view the report. As a UK member of the Committee, we would urge you to reconsider this decision and to comment on the draft report, the subject of which could have far reaching consequences on the Environment Committee's policy areas.

We understand that these include biodiversity, freshwater, soil and landscape character all of which are closely dependent on agri-environment schemes, the funding of which takes place under Pillar II. Unless the CAP is more closely aligned with the

delivery of environmental public goods, it is likely that we will see further declines of biodiversity and further detrimental effects on the wider environment.

We have highlighted the points below, at our meeting with George Lyon, and we recently reiterated these points following the publication of his working document. We feel it is vital that these points are taken into account to ensure that our environment continues to be protected and food production remains sustainable in the long term.

- The need for a reformed CAP to be equipped with the means to deliver a very wide range of environmental public goods, both now and in the future.
- The level of funding to achieve the above will need to be substantial and the report should make a strong case for retaining the financial resources that will be needed to meet existing and future environmental challenges.
- The purposes of a reformed CAP should take into account all the public goods that need to be provided, including preserving cultural landscapes and historic environment features, as well as existing environmental challenges such as preventing biodiversity loss and climate change adaptation/mitigation.

We acknowledge that building support throughout the EU for an environmentally focused evolution of the CAP into a European Sustainable Land Management Policy is undoubtedly a challenge. However, the priorities and proposals contained in the working document appear to be little more than an argument for maintaining the status quo. We are very disappointed that the document does not currently have a timetable for the CAP to evolve into the public goods delivery mechanism that it needs to become in the next decade.

Although we are pleased to see that the report calls for a 'fairer, greener and more sustainable CAP', there appears to be an imbalance between both the number and the detail of farming support measures compared to environmental measures.

We are also aware that the draft report on simplification of the CAP (2009/2155(INI) proposes a reduction in cross compliance requirements thus making the contribution of the CAP to sustainability objectives even more tenuous. Proposals of this kind will be unhelpful in justifying maintaining existing funding levels to the CAP based on its public goods delivery role given the already weak environmental conditions that are applied to its payments.

The argument that it is necessary to maintain the CAP because its income support role will address future food security issues is becoming less convincing in the current economic and political climate and even more so now the apparent supply crisis for some agricultural commodities that occurred two years ago has abated.

Consequently, we would like to see proposals for environmental measures in the draft report strengthened to make the CAP greener and to ensure a strong case is made for increasing the levels of funding for Pillar II of the CAP to ensure its public goods delivery potential is enhanced.
