LINK's Wildlife Forum welcomes report from Rural Affairs, Climate Change and Environment Committee on Scotland's Biodiversity Strategy

LINK's Wildlife Forum welcomes the publication of the Challenge 2020 report from the Rural Affairs, Climate Change and Environment Committee and we look forward to seeing the committee's recommendations incorporated into the government's review. We support the committee recommendations, particularly those on mainstreaming biodiversity into all Scottish Government departments, defining clear and unambiguous roles and responsibilities for delivery and their support for the development of a National Ecological Network. We applaud the committee in having scrutinised Scotland's Strategy for Biodiversity in 2013, Year of Natural Scotland, when we need to take extra steps to safeguard the future for Scotland's nature.

The problem for biodiversity, as members of the Wildlife Forum see it, is that wildlife has no champions in the Scottish Government. As a result, other efforts to conserve and enhance biodiversity by policies outside of 'mainstream' conservation action are weak and under-resourced. This is despite the fact that, in the long run, it is easier and cheaper to achieve biodiversity conservation through, for example, improved agriculture, flood management, planning or forestry policy. We welcome the committee's call for other Parliamentary committees to give consideration to biodiversity in delivering their portfolio

We believe that success now depends on all organisations and businesses delivering for wildlife, and recognising that increasing their positive contribution to nature and landscapes can help them to better meet their own corporate priorities and performance. We support the committee's call for all Scottish Government departments to provide a lead for business, industry and society and the need fro further detail on how the biodiversity duties of public bodies will be met.

Challenge 2020 needs to provide a vision, as well as guidance and leadership on what needs to be done to alter our current trajectory, to reverse rates of change and to
