# Invite to tender Evaluation of LINK's Nature for All project



### 1. Introduction

LINK is the forum for Scotland's voluntary sector environmental organisations – with over 40 members collectively representing around half a million people. It has three strategic objectives:

- Advocating for a sustainable Scotland
- Being a strong voice for Scotland's citizen-led, environment community
- Operating as an effective, efficient, and accountable network

In 2021, LINK conducted a member survey to find out where LINK members were in terms of improving equality, diversity, and inclusion. The results from this survey were shared amongst our members and formed the basis of a funding application to the National Heritage Lottery Fund for the Nature for All project. With the success of the funding bid, this survey now serves as a baseline from which to measure our progress along the equality, diversity, and inclusion journey.

Nature for All aims to build inclusion and diversity in Scotland's environment sector, working with LINK member organisations to provide them with the confidence, skills, and knowledge to increase diversity and provide equal opportunities to those who want to be part of Scotland's voice for the environment. The Nature for All project supports members to implement diversity and inclusion excellence as core values in their own organisations so that the LINK network demonstrates our commitment to equal employment opportunity and positive action.

Scottish Environment LINK ('LINK') is commissioning project evaluation for this 3-year project to measure and demonstrate success and learning from the project design and roll out. This will be a continuous evaluation designed to improve the project and to offer lessons learnt for LINK and our members. It will evaluate the success of delivery and identify the challenges and solutions we meet in improving equality, diversity, and inclusion practices in the environmental sector in Scotland.

### 2. Task

**Project evaluation:** complete a project evaluation, including analysis of performance against stated aims, financial analysis, stakeholder analysis, added value and sustainability, best practice and learning points

### 3. Deliverables

By 28<sup>th</sup> of August 2023: One interim progress report, assessing project delivery to September 2023. This should include event participant feedback for events and member feedback on resources and project deliverables. Success and challenges should be identified and, where possible, lessons for next steps.

By 14<sup>th</sup> of July 2025: At the end of the project, an evaluation report covering the entire project should be submitted to LINK, in draft form. This report will be agreed with LINK's EDI Officer and LINK's CO. The final evaluation report will form part of the project outputs back to the funder, NLHF.
