## The National Lottery Heritage Fund

Dear Mr McFadden,

As you consider the future of public bodies, we are writing to emphasise that National Lottery Heritage Fund has an essential role to play in meeting the Government's Environment Act 2021 duty to halt the decline of nature by 2030.

No doubt as you have considered your Department's role in cross-government coordination of the Environmental Improvement Plan, you will have been made aware of the significant funding and delivery gap in efforts to meet the Government's nature commitments.

NLHF is one of the few organisations that can help to fill that gap in a cost-effective and socially progressive manner. The Fund has delivered over £2.2bn in funding for environmental projects (23% of its overall funding), restoring natural infrastructure that underpins economic resilience, and boosting green spaces in and around towns and cities with huge health and wellbeing benefits.

If the Fund were to be subsumed in another public body with a less clear focus on natural heritage, its ability to fulfil that role could be lost and the Government's ability to meet its Environment Act targets and net zero mission could be compromised. It is also important that the Fund takes a four-country approach, which few other bodies can deliver. We recommend that NLHF remains in its current form, continuing its vital role of investment in the UK's priceless and fragile natural heritage.

We would be glad to meet to discuss the Fund's future and your wider review of public bodies if that would be helpful.
