Re: The National Lottery Heritage Fund

Dear Cabinet Secretary,

The UK Government is considering the future of <u>public bodies and quangos</u>. We have heard that the National Lottery Heritage Fund (NHLF) is to be considered as part of this review, and that it could be subsumed into a single UK public body. If this were to happen then we are concerned that its ability to fund projects in Wales could be lost and both UK and Welsh Government's ability to meet their biodiversity and net zero commitments could be compromised. There is significant value in funding cultural and natural heritage together, and NLHF is uniquely placed to do this. As such, we recommend that NLHF remains in its current form with devolved governance and staff in Wales, so that it can continue to deliver the vital investment in our priceless and fragile natural heritage.

The NHLF has an essential role to play in meeting the Welsh Government's commitments under the Global Biodiversity Framework and to achieve future nature targets that will be set under the framework of the Environmental Governance, Principles and Nature Targets Bill.

There is a significant funding and delivery gap in efforts to meet both the UK and Welsh Governments' nature commitments. NLHF is one of the few organisations that

can help to fill that gap in a cost-effective and socially progressive manner. The Fund has delivered over £2.2bn in funding for environmental projects (23% of its overall funding), restoring natural infrastructure that underpins economic resilience, and boosting green spaces in and around towns and cities with huge health and wellbeing benefits. Since leaving the EU, the Fund is now one of, if not the most significant nature funders in Wales and a trusted grant delivery body for Welsh Government funds for nature, such as the Nature Networks Fund. The most recent "Where the Green Grants Went" report shows that Wales received significantly more in terms of Lottery funding than it does in funding from Foundations. Indeed, there are few long-term funds for nature available to Wales, so any loss of Lottery funding for nature in Wales would present serious challenges for nature conservation and restoration work.

We ask for reassurance that you will make representations to the UK Government on the importance of the Fund for Wales. We would be glad to meet to represent our concerns and outline the NLHF's vital importance for Wales if this would be helpful.
